PARTICIPATION AND WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. I affirm that I am the parent or legal guardian of _____ (hereinafter referred to as "Participant"), and I consent to Participant taking part in the Monsoon Wrestling Club ("Club") activities. I understand that the Club is a non-profit organization that will rely upon people and entities voluntarily provide the Club with services, facilities, and equipment (herein collectively referred to as "Benefactors"). I understand that without these Benefactors, the Club would not exist and Participant could not take part in Club activities.
2. In consideration for receiving permission to participate in the Club, I hereby RELEASE, WAIVE, DISCHARGE AND AGREE NOT TO SUE the Club, Benefactors, and the volunteers, agents, employees, officials, officers, directors, officers, agents, servants, or employees of both the Club and its Benefactors (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, that may be sustained by me or Participant, or any property belonging to me or Participant, while participating in such activity, or while in or upon the premises where the activity is being conducted
3. I am fully aware of the risks involved and hazards connected with the Club activities, including but not limited to wrestling, running, travel risks, exercise, and amusement activities. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me or Participant and my property or Participant's property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me or Participant, or any loss or damage of property owned by me or Participant, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
4. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
5. I understand that the Club does not maintain any insurance policy covering any circumstance arising from participation by me or Participant or any activity associated with or facilitating that participation. As such, I am aware that I should review my personal insurance portfolio.
6. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Agreement shall be construed in accordance with the laws of the State of Arizona.
7. I hereby expressly consent to authorize the Club and Benefactors to take, produce, and publish photographs taken of Participant without compensation and I understand that such photography constitutes a club activity.
8. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
